

Student-Athlete Financial Aid FAQ

University of Iowa Athletics Department

In addition to university requirements, student-athletes must also meet NCAA requirements for scholarships and financial aid. If you are a student-athlete (SA) at the University of Iowa, or interested in becoming a student-athlete, the following has been created to answer any questions you may have.

Q. How do I apply for financial aid at the University of Iowa that is not related to athletics?

- A. There are a few merit scholarships that are awarded by the UI Office of Admissions. You are automatically considered for these scholarships based on your high school academic achievements when you apply for admission. You will be notified of these scholarships when you are officially admitted.

To be considered for need-based scholarships, grants, loans, and work-study, you are required to complete a Free Application for Federal Student Aid (FAFSA). The FAFSA is available on October 1st. The FAFSA filing deadline for priority consideration is November 15. Financial aid is awarded first-come first-served based on the completion date of your financial aid file. Q. Do I need to complete a Free Application for Federal Student Aid (FAFSA)?

- A. It is highly recommended because it is a requirement for qualifying for need-based aid. In addition to need-based aid, all students can be considered for Federal Direct Loans up to the cost of their education. Even a full athletic grant does not cover the estimated personal and transportation expenses that are built into every student's cost of attendance and financial aid may be available to assist with these expenses.

Q. What kind of aid can I accept?

- A. You should accept all aid when initially offered. If you decline institutional aid when it is offered during the admissions process, it is lost forever. If you accept the admissions award, it may be available annually.

All aid for a given SA is evaluated annually by the athletics department and the financial aid office. The permissibility to receive the aid may vary year-to-year dependent on current rules, the sport's scholarship situation, or the SA's overall academic or financial status.

Q. Am I considered a recruited student-athlete?

- A. For financial aid purposes, the NCAA has defined a recruited student-athlete as one who (a) was provided an expense paid official visit to campus; (b) had an arranged, in-person, off-campus encounter with a member of the UI's coaching staff; or (c) was issued a National Letter of Intent or a written offer of athletically related financial aid.

Q. Can I apply for additional private awards?

- A. You should apply for as many grants/scholarships as possible through local community agencies, your high school, national competitions, etc. Your high school guidance counselor may be able to assist you. Always accept awards offered. Always declare those awards during your annual student-athlete certification meeting that occurs at the start of the academic year. Athletics is required to review the criteria for outside awards and will ask for your assistance in contacting the awarding agency to complete the Student Athlete Financial Aid Form (SAFA), which will be sent to you at the beginning of the academic year.

Q. Why would my aid have to be returned or reduced after I accept it?

- A. It is possible that the University will determine some money cannot be accommodated. Reasons can include (a) your total aid exceeds your Cost of Attendance (COA) limit, (b) your countable athletics aid exceeds the NCAA athletics grant-in-aid (GIA) limit, or (c) NCAA rules require that your non-athletics aid counts against the sport's allowable scholarship total and cannot be accommodated.

Exempted Institutional Financial Aid. The following institutional financial aid is exempt and is not counted in determining the institution's financial aid limitations:

- (a) An institutional need-based grant awarded based solely on demonstrated financial need, as determined for all students by the institution's financial aid office using methodologies that conform to federal, state and institutional guidelines. However, such aid is not exempted for purposes of determining a football or basketball student-athlete's counter status.
- (b) A nondiscretionary institutional merit-based award with no relationship to athletics ability awarded based on documented criteria that apply to all students. However, such aid is not exempt for purposes of determining a football or basketball student-athlete's counter status.
- (c) An honorary award for outstanding academic achievement or an established institutional research grant that meets the criteria and must be included in determining if the student-athlete's cost of attendance has been met.

Q. Can I get an early estimate of financial aid?

- A. Incoming first-year and transfer students can utilize the Net Price Calculator (NPC) available on the Admissions and Financial Aid websites (www.admissions.uiowa.edu/finances or <https://financialaid.uiowa.edu/resources/calculators>) to receive an early estimate of your expected family contribution, your potential merit awards from Admissions and your merit/need-based awards from the Office of Student Financial Aid. **You will need your academic information and parental income and assets to complete the NPC.** This information is only an estimate and may vary based on the accuracy of the information you provided and the completion date of your financial aid file.
